COMPONENTS OF COURT ROOM

1.A large dais to accommodate a large table and an executive chair with sufficient space for movement towards the sides and rear.

2.The dais should be raised by about 450 to 600 mm from the court room floor level.

3. The dais has to be directly approachable from the judge's chamber.

4. The size of the judges table on the dais should be large enough to accommodate two chairs.

5. The table should have provision for power outlet, computer LAN outlet and video conferencing facilities.

Witness box, etc.

1.A witness box of proper size and design (with hand rails).

2. The witness box should be raised by 150 mm to 200 mm from the court room floor level and should have a chair for sitting.

3.An enclosure for the accused on the other side of the dais facing the witness box with a bench capable of seating at least 3 persons

Space for two tables: one for the court master (Reader) and one stenographer, in front of the dais with provision for electrical points for connecting computers

Lawyers desks, designed to have space for storage of books and files.

Space for lawyers to stand and argue etc.

- TIKRI KALAN is a census town city in West Delhi district in the INDIAN state of Delhi. Elevation / altitude is 214 meters above seal level. The Pin code is 110041.
- This place is dominated by 'DRALL' gotra of JAT community . this village gets its name from the TIKA DRALL.

Demographics

- There are nearly 3,455 houses in the census town. As per census INDIA 2011, TIKRI KALAN census town has a population of 16,313 of which 9,247 are males while 7,066 are females.



- All the courts started functioning under several roof. At present the total strengths of the judicial officers at Muzaffarnagar is 43.



- Site is in 1 km radius the total area of Muzaffar Nagar are 4008 sq. mt.


